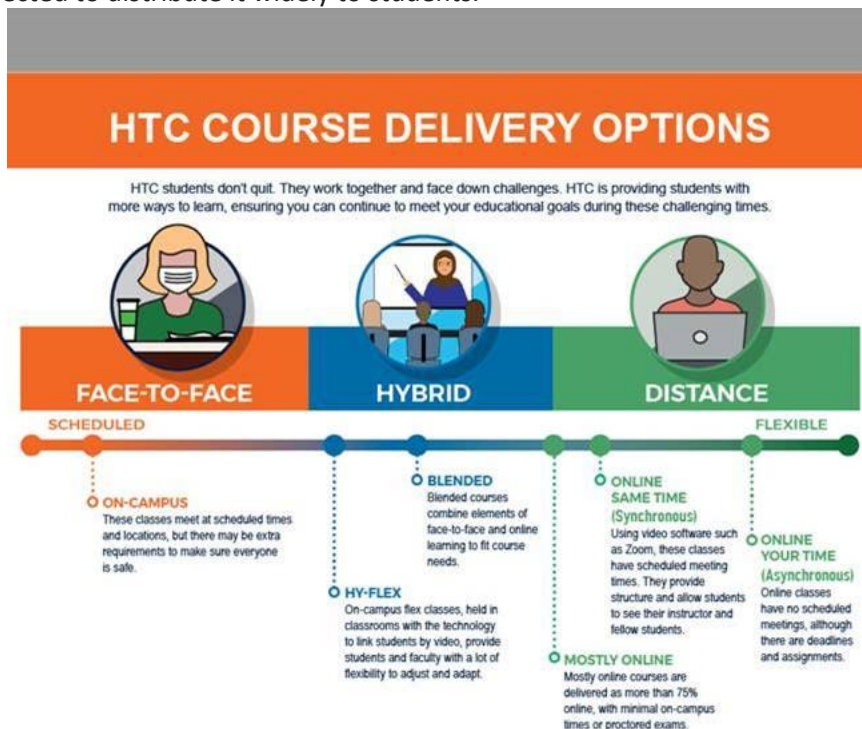

- b) Spring drop for non-payment – Due to the pandemic, the Board of Trustees has permitted each institution to decide whether to drop students for nonpayment each term this year. HTC did not drop students for non-payment for summer or fall term. Several students remain unpaid (in full or at all), so we have decided to do a drop for non-payment for the spring semester on Friday before classes begin. That means that students who have not arranged for payment by one of the following options will be dropped from their spring classes on Friday, January 8, 2021. Enrollment Services is regularly reaching out to students in this situation.
