#### Concern

A concern is: sharing information about something that affects, interests, or worries a student that the institution should know about.

#### Complaint

A complaint is: an informal claim alleging improper, unfair, or arbitrary treatment.

A complaint is not: disagreement with an administrative decision or the outcome of an appeal of that decision, unless it alleges improper, unfair or arbitrary treatment.

#### Grievance

A grievance is: a written, formal claim alleging improper, unfair or arbitrary action that violates a **specific** policy, procedure or practice of HTC or the MnSCU system.

A grievance is not: disagreement with an administrative decision or the outcome of an appeal of that decision, unless it alleges violation of a **specific** policy, procedure or practice of HTC or the MnSCU system.
